Sealed quotations are hereby invited by the undersigned on behalf of The President of India for supply and fittings of 1253.48 sq.mtr Linoleum carpet (LG-1.5 mm thickness) to this office complex. The envelope containing the quotation should be properly wax-sealed and superscripted in bold letter on top as “QUOTATION FOR LINOLEUM CARPET”. The quotation should be sent to the “Additional Commissioner (P&V), Central Excise, Post Box No. 8, Morello Compound, M.G. Road, Shillong-793001” either by post or it may be delivered by hand during office hours.

The quotations shall be submitted according to the terms and conditions specified in paragraphs 1 to 8. Unless specified other wise in the quotation, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.

1. The rates should be F.O.R and should be inclusive of all taxes, delivery & freight charges, any other taxes, rates or imposition whatever liable in respect of the supplies. The Central Excise office, Shillong shall not be liable to pay any tax, freight etc. separately which has been expressly stipulated in the quotation in the event of acceptance of the quotation.
2. The installation charges plus applicable tax, if any should be indicated separately
3. There should be no overwriting or correction in the quotation. If a figure is to be amended, it should be neatly scored out and the revised figure written above and the same attested with full signature and date. In the absence of attested signature, the quotation is liable to be rejected.
4. The undersigned does not bind himself / herself to accept the lowest quotation but reserves the right to accept the quotation in whole or in part, i.e., with respect to all articles mentioned in the enclosure or in respect of any one or more than one articles specified in the enclosure as he/she may decide.
5. Proper description /specification, size, thickness and brand of the article as desired should be clearly indicated.
